NOTIFICATION

In exercise of the powers conferred by section 102 of the Rajasthan Panchayati Raj Act, 1994 (Act No. 13 of 1994) and all other powers enabling it in this behalf, the State Government hereby makes the following rules further to amend the Rajasthan Panchayati Raj Rules, 1996; namely:-

 <u>Short title and commencement</u>.- (1) These rules may be called the Rajasthan Panchayati Raj (Amendment) Rules,2007.

(2) They shall come into force on the date of their publication in the Official Gazette.

- Amendment of rule 157.- In rule 157 of the Rajasthan Panchayati Raj Rules, 1996, hereinafter referred to as the 'said rules';
 - (i) after the expression "Regularization of old houses.-" and the before the expression" Where the person", the figure "(1)" shall be inserted.
 - (ii)after sub-rule (1) as so numbered, following new sub- rule (2) shall be added; namely-

"(2)Families who do not have any house or house site anywhere and are in possession of abadi land by way of construction of a hutment/kutcha house upto year 2003, shall be entitled for regularization of possession maximum upto 300 yards free of cost. The patta of such land shall be issued in the name of women head of such family."

- 3. Amendment of rule 158 .- In sub-rule (2) of rule 158 of the said rules;
 - (i) after the existing proviso, following new proviso shall be inserted; namely:-

"provided further that in case of allotment of abadi land to the families of below poverty line, the panchayat may allot the land free of charge".
