Dear Madam/Sir,

A mega event, kick-starting year-long celebrations has been proposed by the Ministry of Tribal affairs on 15th November 2024 with State, District and Block level events across the country.

2. It is pertinent to mention that Ministry of Panchayati Raj has been emphasising for effective implementation of Panchayat Extension in Scheduled Areas (PESA) Act and collaborated with the Ministry of Tribal Affairs (MoTA) for the Special Capacity Building Campaign for the Panchayats and key stakeholders for strengthening of Gram Sabhas and effective PESA Act and Forest Rights Act (FRA).

3. Accordingly, Ministry has conceptualised to organise special **Gram Sabha cum-orientation/training programme in the PESA and FRA villages on 15th November, 2024**, wherein various activities mentioned in **Annexure-I** is to be carried out along with Capacity Building & Training of Elected Representatives, Functionaries and other Stakeholder of Gram Panchayats/ Villages identified in your State/UT by Ministry of Tribal Affairs (List at **Annexure-II**).

4. Further, to organize the orientation-cum-training programme on FRA & PESA during the special Gram Sabhas, **the expenditure up to Rs.10000/- per Village (as per Annexure-II) may be booked under the Capacity Building & Training component of RGSA**. The amount is to be provided to the identified GPs / villages for successful organisation of the said special Gram Sabha, as per the prescribed structure.

5. I, therefore, shall be grateful for your personal intervention in issuing necessary direction for organizing the proposed programme and releasing requisite funds to the aforesaid Gram Panchayats/ Villages as mentioned in para 4 above, to organize special Gram Sabha cum- orientation/ training programme and also to facilitate and provide other necessary support to organize the program successfully.

1. Issuance of notice for Convening special Gram Sabhas on 15th November 2024 at the PESA Villages/Gram Panchayats having Tribal population. An indicative list of Villages shared by Ministry of Tribal affairs is attached as Annexure-A.
2. General invitation to the members of Gram Sabha.
3. Invitation to special invitees (if any)
4. Identification of venue (priority to be given to Community Hall) and preparation at the venue including tent (if the venue is open air), chairs, lights, mike/ sound system, refreshment etc.

Program Structure:

1. Opening remarks by Sarpanch / Head of GP or any other Elected Representative/ person presiding over.
2. Reading of Preamble to the Constitution.
3. Taking pledges on Swachhata and against drug abuse.
4. Honouring the Special invitees by the GP Sarpanch and Members.
5. Tree plantation (**1 Ped Maa ke Naam**). The Special invitees to be assisted in planting the trees which can be named after them and, wherever possible, fruit bearing trees to be planted.

Subject: Celebration of Janjatiya Gaurav Divas on 15th November, 2024 - regarding

The undersigned is directed to intimate that the Janjatiya Gaurav Divas (JJGD) is celebrated on 15th November to honor all the tribal freedom fighters and for remembering and acknowledging their contribution to the freedom struggle and cultural heritage, and to re-energize the efforts for the socio-economic development of the Tribal regions. The 4th Janjatiya Gaurav Divas 2024 will be celebrated by the Ministry of Tribal Affairs during the period commencing from 15th November 2024 and leading up to 26th November 2024 to coincide with the constitution day across the country. Further, Ministry is commemorating 150th birth anniversary of Bhagwan Birsa Munda next year and year-long celebrations will be held throughout the country from 15.11.2024 to 15.11.2025, which will include efforts to promote tribal art, culture, heritage, and history, alongside programs showcasing the role played by tribal communities in the Indian freedom struggle along with ensuring an impact on their socio-economic development.

2. As Ministries/Departments of Government of India are important stakeholders in ST welfare and development, it is therefore, requested to participate in the celebrations of the Janjatiya Gaurav Diwas and in the year-long celebration (Janjatiya Gaurav Varsh) to commemorate the 150th birth anniversary of Bhagwan Birsa Munda. The period from 15th November 2024 and leading up to 26th November 2024 may be celebrated by undertaking such activities as (i) inauguration or foundation stone laying for infrastructure projects or disbursal of benefits targeting the tribal population undertaken with TSP funds; (ii) launch of initiatives/schemes (iii) capacity building activities for sector specific matters oriented towards tribal population (iv) public awareness campaigns in areas with predominantly tribal population on various schemes and other initiatives relating to tribal development; (v) documentation of best practices, success stories, innovative initiatives, digitization and database management (vi) maintenance of disaggregated data of ST beneficiaries of schemes and analysis thereof so as to ensure that the benefits reach them and (vii) any other initiative/activity that is fit to be taken up under the Janjatiya Diwas celebrations during the period. This will ensure the adoption of the whole of government and whole of India approach in tribal welfare and development.

3. It is also requested to prepare a calendar of events and share the same with us for our information. Further, a Nodal Officer from the Ministry/Department may be appointed at the level of Director to coordinate with the MoTA for the celebrations/programmes during JJGD/JJGV. The nodal officer would be responsible for sharing the calendar of events for the period from 15th – 26th November and for the entire commemorative year up 15th November 2023. He would be required to attend meetings of the MoTA, prepare the calendar of activities of your Department, implement the same and upload the details thereof in the portal of the MoTA at <https://adiprasaran.tribal.gov.in/JJGD/>. He would also be required to coordinate the conduct of the events during the JJGD period from 15th to 26th November, 2024 and upload the documentation of events with photographs and videography in the designated portal of the MoTA.

A mega event, kick-starting year-long celebrations has been proposed by the Ministry of Tribal affairs on 15th November 2024 with State, District and Block level events across the country.

2. It is pertinent to mention that Ministry of Panchayati Raj has been emphasising for effective implementation of Panchayat Extension in Scheduled Areas (PESA) Act and collaborated with the Ministry of Tribal Affairs (MoTA) for the Special Capacity Building Campaign for the Panchayats and key stakeholders for strengthening of Gram Sabhas and effective PESA Act and Forest Rights Act (FRA).

3. Accordingly, Ministry has conceptualised to organise special **Gram Sabha cum-orientation/training programme in the PESA and FRA villages on 15th November, 2024**, wherein various activities mentioned in **Annexure-I** is to be carried out along with Capacity Building & Training of Elected Representatives, Functionaries and other Stakeholder of Gram Panchayats/ Villages identified in your State/UT by Ministry of Tribal Affairs (List at **Annexure-II**).

4. Further, to organize the orientation-cum-training programme on FRA & PESA during the special Gram Sabhas, **the expenditure up to Rs.10000/- per Village (as per Annexure-II) may be booked under the Capacity Building & Training component of RGSA**. The amount is to be provided to the identified GPs / villages for successful organisation of the said special Gram Sabha, as per the prescribed structure.

I, therefore, shall be grateful for your personal intervention in issuing necessary direction for organizing the proposed programme and releasing requisite funds to the aforesaid Gram Panchayats/ Villages as mentioned in para 4 above, to organize special Gram Sabha cum- orientation/ training programme and also to facilitate and provide other necessary support to organize the program successfully.
